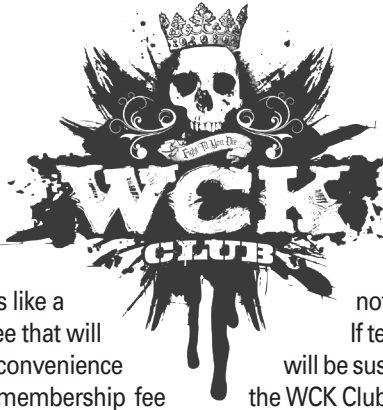


# MEMBERSHIP
